Learning from Home - Remote Learning Option

Families who have concerns about their child's health or impact on a family member with high risk factors may choose to have their child engage in a completely virtual instructional option. It should be noted that while a virtual instructional experience will be substantive, it will not be equivalent to an on-site/in-person learning experience. The completely virtual option will entail live and/or recorded lessons. The objective is to provide students with the resources and instruction necessary to master the content.

Procedures and Requirements for Remote Learning

- Parents should notify Moriah Elementary of the intent to enroll their student(s) in the Remote Learning program by completing the "Moriah Elementary Remote Learning" online form. This should be done no later than Friday, August 14.
- Remote Learners are asked to commit to Remote Learning for the duration of the first trimester.
- Remote Learning will be offered for the 2020-2021 school year unless COVID restrictions are lifted by the Governor, State Education Department or any agency with authority over the operation of schools.
- The current attendance policy will apply to all students in accordance with NY State regulations. Daily attendance of Remote Learners is required and recorded.
- Students who take part in Remote Learning will join a live or recorded video stream of classroom instruction as scheduled by the classroom teacher.
- Students will follow a daily schedule and have the same expectations as on-site students. Accommodations will be made for students who do not have internet access.
- Students will be expected to participate/be available for live instruction/interaction during the pre-scheduled times throughout the day.
- Instruction will be provided in ELA, Math, Science, and Social Studies for each grade level. Remote learning will likely include modifications to onsite activities such as physical education, music, library and art.

- Remote Learners will be responsible for attendance, assignments, virtual meetings, assessments, and participation in live instruction when assigned.
- Students in grades PreK-2 will most likely need a parent available at all times to effectively complete Remote Learning.
- Remote Learners will receive standards based grades and report cards.
- Remote Learners receiving Special Education Services will continue to receive appropriate instruction in accordance with students' IEPs.
- Parents will be expected to attend a virtual parent-teacher conference within the first trimester, or when there are significant concerns, to discuss how remote students are progressing.

HomeSchool Option

Families who prefer to not have their child attend Moriah Elementary School District in-person, or participate in Remote Learning requirements in accordance with State Education guidelines, may exercise their right to HomeSchool their child. Parents interested in the HomeSchool option should contact the District Office (ext. 501) to file their Individual Home Instruction Plan.
